NOTICE OF CONTINUUM OF CARE HOMELESS HOUSING, ASSISTANCE AND PREVENTION (HHAP) PROGRAM NOTICE OF FUNDING AVAILABILITY

Monterey/San Benito Counties, California— The State of California recently allocated separate funding streams to Counties and Continuums of Care. On March 4, 2020, Coalition of Homeless Services Providers (CHSP), the local Continuum of Care, issued its Notice of Funding Availability (NOFA) for the Homeless Housing, Assistance and Prevention (HHAP) Program. Eligible activities include; operating and/or supportive services for new or existing homeless beds; rental assistance, rapid rehousing, eviction prevention and/or move-in assistance; landlord mitigation; street outreach programs; innovative solutions; new navigation centers or emergency shelters based on demonstrated need; housing navigation services; targeted case management and other related activities. **NOTE: All local HHAP Project Applications are due by 5:00 p.m., April 30, 2020.** A **mandatory** pre-proposal conference will be conducted at from 1:00 to 3:00 on March 19, 2020 at 1942 Fremont Boulevard, Seaside for all interested applicants. Applications received from organizations that do not attend pre-proposal conference will not be considered for funding.
