#### 5. Brief Updates

Wilson provided the Council with the following updates:

- A. COVID-19 Update—Wilson explains that The Coalition of Homeless Services Providers' clients that were sheltering at the same location as the county's clients have been inducted into the county's Project Roomkey Program. This significantly changed the strategy for The Coalition to find exit strategies for these clients. To date, The Coalition has connected 70 of the 165 clients to some sort of housing intervention. Whether that would be Rapid Re-housing, permanent supportive housing, and transitional housing. Clients started moving out about a week ago. At this very moment, it is possible that the county's program may shut down next week. Medina explains that there will be a meeting tomorrow about this issue. Wilson then explains that The Coalition is trying to work with other partners to gain funding to help financially sustain the project in order to find housing for clients. Wilson then speaks about the sanitation stations, and the contract was supposed to end in May but has found funding to keep them out there for about 1 more month. They have worked out to split the bill with the city of Salinas to keep these stations for a longer period of time.
- B. **State ESG-CV2** There is another wave of emergency funds called ESG-CV2. Wilson explains if they use the same formula as our last wave we will receive about 2.5million in emergency funds for homeless. The Coalition has been in contact with the City of Salinas to use this funding to cover some of the gaps in funding for the projects that couldn't be covered with HHAP. The Pandemic and various sources of funding have promoted healthy communication between The Coalition, City of Salinas, County of Monterey and our foundation partners. Wilson explains that it has become clear that there should be a funding committee, to figure out how funding is distributed especially since the 10-Year Plan rewrite will be completed by next spring.
- C. **100-Day Challenge** Wilson quickly reviewed the status of the 100 Day Challenge to End Youth Homelessness, and to keep an eye out. The goal is to house 100 Youth, 70% Pregnant and Parenting and 20% in the criminal system/trafficking/DV/foster care and the rest to be youth that do not fit in these categories. Should we get YHDP grant, it will roll in at least \$1M a year for youth homelessness and after a couple of years will roll into our CoC grant.

## **6. State ESG-CV1 Funding Recommendations: (Attached)**

Hunter presents the allocation of funds. They received this application June 1<sup>st</sup> and is due July 20. Due to this being emergency funding, the City was not required to release an RFP, and instead directly funded organizations that were already providing COVID related services. Hunter then presented the action plan, or where funding would be allocated.

Wilson thanked the ranking committee for their commitment to The Coalition and to the clients that we serve. Wilson then reviewed where funding recommendations and the ranking of projects. Wilson also provided reasoning for decisions as well as other funding that programs could apply for if they were not chosen. There is possibly a HHAP round two.
