### 5. Brief Updates

Wilson provided the Council with the following updates:

### CoC new grant

HUD announced another CoC- funding stream targeting unsheltered persons. At this time there is no further information.

### YHDP/100 Day Challenge

CA-506 to participate in the 100 Day Challenge to End Youth Homelessness, which is an activity across the nation that significantly positions ourselves to compete for the YHDP grant. If approved, the YHDP grant will bring in no less than \$1m into our community and will eventually roll into the CoC program.

### o COVID-19 Update

CHSP is working very closely with EOC on getting Project Roomkey and the COVID+ response stood-up.

### HHAP Updates

CHSP officially released the NOFA. Bidding conference held on Thursday, March 19, 2020. Wilson reported that although the State is encouraging CoCs to use the money of HHAP & HEAP for COVID-19 response, she is working with the County to find other funding streams to address the crisis.

#### 6. CH Solutions Contract Amendments (Attachment):

CHSP received written notification that Community Homeless Solutions intends to forfeit all three of their 2019 HUD CoC grants. CHSP has worked closely with HUD to understand the limits in which the CoC can handle this situation and recommended the following for Leadership Council approval:

- 1- Homeward Bound (25 families/\$118,209) and MOST/Lexington (6 families/\$101,336) contracts to reflect Housing Authority as the agency responsible for administering grants (\$219,545).
- 2- Men in Transition (24 unaccompanied adults/\$169,772) to reflect Interim, Inc. as the grant administrator.

### 10.CESH/ESG NOFA:

The California Department of Housing and Community Development (HCD), through the California Emergency Solutions and Housing (CESH) Program, has made funding available to the Salinas/Monterey, San Benito Counties Continuum of Care CA-506 (CoC) to provide grants to assist persons who are currently experiencing homelessness or are at risk of homelessness. The City of Salinas (City) has been designated by the CoC as the Administrative Entity (AE) for CESH and as a result is issuing a competitive Notice of Funding Availability (NOFA). The AE applied to HCD on June 28, 2019 and was awarded \$562,293 of CESH funding through HCD on October 7, 2019. The funding will be distributed between the eligible CoC service areas based on the percentage of homeless from the most recent 2019 Point-in-Time (PIT) Count. The AE will utilize the full 5 percent administrative allocation totaling \$28,114. The remaining CESH allocation may be distributed between Monterey and San Benito County based on the most recent 2019 PIT Count. Approximately \$479,179 is available in Monterey County and up to \$55,000 for San Benito County. CESH limits operating support for emergency housing interventions funding to a maximum of 40% or \$224,910.

City of Salinas requested the Leadership Council to approve the proposed timeline & authorize the City to publish the Notice of Funding Availability (NOFA) in April 2020.

### 11. HEAP Update:

Wilson provided an overview of the HEAP spenddown status.(Attached.)

- \$1.1M has been spent to date on HEAP funded projects "\$260k on Youth, \$665k on Capital, \$120k on Services, \$107k on RA/RRH".
- 400+ individuals and families served by HEAP funds.
- \$8.6M Allocated to capital projects for the building, rehabilitation, or acquisition of multiple housing types.
- 14 individuals and families have been housed using Rapid Rehousing/Rental Assistance HEAP funds.
- A total of 274 beds will be created and added to our housing inventory for people experiencing homelessness.
- 12 Youth receiving case management services through the Salinas Valley Street Outreach Program (SVSOP).
