## 1. Welcome, Introductions, and Announcements:

The meeting began at 3:30 PM. Introductions were made to keep order to the call.

#### 5. Homeless Housing Assistance Program (HHAP) Round 4 Funding:

a. CSUMB Community Health Engagement (CHE) Proposal Genevieve led a presentation with the total funds broken down for HHAP 4 and proposed approval of \$255,00 for CSUMB CHE. Genevieve Lucas-Conwell emphasized the great successes of CSUMB CHE.

Clifford Andrews, CHE Outreach Manager, outlines CHE's work in the community. CHE consists of three (3) outreach workers and an outreach specialist and student undergrads in social work and nursing. They work with engagement seven days a week, case management, housing navigation support, and primarily boots-on-the-ground from King City to Pajaro levy and everything in between on the Peninsula side as well. They go through towns, riverbeds, hilltops, and train tracks and walk the streets daily to find and help those in need. The main goal is to connect people with services and resources that they normally would not get especially in rural communities in Pajaro, King City, and Soledad. CHE connected and engaged 430 individuals/households this fiscal year. However, they were unable to track a lot of the engagement in HMIS because a lot of homeless individuals we encountered are uncomfortable sharing their personal information.

Recommended Motion: To approve \$225K of HHAP 4 funds for CSUMB CHE.

### **Questions/Comments:**

Lauren Suwansupa and Roxanne Wilson made comments in support of these funds being approved.

Anna Velazquez – Inquired if there was more data on where CSUMB CHE is concentrating/working on.

Mike LeBarre - Mentioned that their City Manager was very grateful for CSUMB CHE's work.

Timothy Heavin – Praised CSUMB CHE's work.

Motion to approve made by Mike LeBarre, seconded by Roxanne Wilson. No abstentions. No oppositions. Motion carried unanimously.

#### 6. Coordinated Assessment & Referral System (CARS):

- b. Emergency Housing Vouchers (EHV) & Pajaro Update
  Due to Zuleika Boykin's efforts, EHV utilization has increased from 30% to 50%. Currently, 180
  folks are housed with EHV and 80 people were handed vouchers. Zuleika Boykin confirmed they
  are doing very well with EHVs they are working to get them out by the end of September 21,
  2023. These include referrals for Pajaro, with a prorated voucher working with Central Coast
  Center for Independent Living (CCIL) to support them to get to 30 households, and 29
  unduplicated vouchers will be dedicated to San Benito County. The vouchers are in the hands of
  people housing navigators are needed to assist them.

Roxanne – Acknowledged that HAMC, CCIL, and CHSP will be doing direct outreach for people in Watsonville that were misplaced by the Pajaro floods.

#### c. Overhaul Timeline

An overhaul in August is anticipated, at the end the of HUD NOFO period. Looking at the assessments to get folks into housing.

Recommended Motion: To approve CARS addendum.
